



COVID-19 Weekly Summary Report

March 26, 2021

Dear Hampton Families:

Allegheny County’s incidence rate per 100,000 cases is 140.3, and the percent positivity is 7.7%. This is a substantial increase from last week’s data and places the County in the **High** Transmission Level using CDC guidance. When considering the second prong of the criteria, the High School had two in-school cases since the last report, and the Middle School had one.

Two-Pronged Approach for Phased Reopening

Moderate Transmission in Allegheny County (CDC guidelines) ¹

AND

Two consecutive weeks of minimal HHS/HMS positive cases (0-2 weekly) ²

- Total New Cases Per 100,000 = **10 - 49**
- Percentage of NAAT’s that are positive during the past 7 days = **5.0%-7.9%**

	Middle and high schools in hybrid learning mode or reduced attendance Physical distancing of 6 feet or more is required.	Middle and high schools in virtual only instruction unless they can strictly implement all mitigation strategies and have few cases; schools that are already open for in-person instruction can remain open, but only if they strictly implement mitigation strategies and have few cases.
