

Mrs. Hamlin asked if all positions are standard positions, or if any are additional staff that will be needed for the fall.

Dr. Loughead replied that item #4 is a new, budgeted-for position that makes an existing long-term substitute at Poff a full-time contracted position. The original hire several years ago was made to reduce class size, and enrollment has remained consistently high. He also noted the slight increase in the Wyland special education teacher's hours from .5 to .6, due to increased enrollment.

Dr. Cunningham added that item #24, the hiring of a paraeducator at Poff and the high school, is also a new position due to increased enrollment in the special education program.

#### Summer 2020 Capital Projects Update

Mr. Kline updated the Board on two capital projects at Hampton Middle School. He said Mr. Rick Farino, District Buildings and Grounds Supervisor, informed him a pre-construction meeting was held July 28 with Mr. Farino and representatives from VBA and the two contractors, Graciano Corporation and Hranec Corporation present.

Graciano, the company which is replacing through-wall flashing, will begin work on August 10. Hranec, the company which is replacing two air handling units, has ordered materials, which have an eight to 10 week lead time. Installation is expected in October and November.

#### **Student Affairs Agenda**

Board Members considered two items, on which they are expected to vote at the August 10 meeting:

#### 2020-2021 Elementary Parent Handbook

Most revisions are not substantive, Dr. Cunningham said. More substantive revisions include the following:

- Changing all references from "parent" to the more inclusive "parent/guardian."
- Increasing the number of approved absences from five to 10.
- Adding "If renting an instrument is cost prohibitive, please contact the band director, orchestra director or elementary school counselor for assistance."

#### **Transportation Agenda**

#### 2020-21 Transportation Routes and Rates

Mr. Kline said he hoped to have the full list of transportation routes, along with rates, to the Board on August 10 for a vote on approval. The routes are not made public, he noted, but parents and students will be able to retrieve bus assignments and times through Infinite Campus about a week before school starts.

#### Provision of Alternative Transportation Solutions

Mr. Kline outlined the proposed alternative transportation agreement with ALC Schools, LLC. The contract addresses the problem of getting Hampton students who are homeless or placed outside of the District to District schools, he said. These students are generally coming from the City of Pittsburgh to Hampton, which is the opposite direction of existing bus routes, and the bus driver shortage means there is no personnel to run such a bus. ALC Schools, LLC would provide an Uber-like ride service, he said. The Board is expected to vote on the proposal at its August 10 voting meeting.

In response to Board questions, Mr. Kline said ALC is already working in the area, and he would add clarifying language to be sure the company is conducting background checks and drug and alcohol screens consistent with District standards.

## Hampton Township School District Reopening Strategy Recommendation: Learn at School / Learn at Home Hybrid

21:31 to 1:24:32

Dr. Loughead provided an overview of the recommended Learn at School/Learn at Home Hybrid Model, which the Reopening Committee and Administrative Team believe is the best and safest option for students, faculty, and families. This model:

• Calls for groups of students to alternate between in-person instruction at school and remote learning at home.

- Reduces the number of students at school by 50%, which facilitates maximum social distancing, makes health monitoring easier, enhances the ability to conduct contact tracing, and increases the ability to keep schools open.
- Enables students to use technology at home to participate in at school learning.
- Enables all mitigation strategies, including face coverings, social distancing, hand washing, and frequent cleaning, to be maintained.

#### Logistics details:

- All students Learn at School two days a week and Learn at Home three days a week.
- Students with last names starting with the letters A-K (Pod A) Learn at School on Mondays and Tuesdays and Learn at Home on Thursdays and Fridays.
- Students with last names starting with the letters L-Z (Pod B) Learn at School on Thursdays and Fridays and Learn at Home on Mondays and Tuesdays.
- All students Learn at Home on Wednesdays.
- Wednesdays allow for cleaning of buildings, teacher-supported differentiated instructional activities, developmentally appropriate designed learning, and teacher planning and preparation.

#### A.W. Beattie Career Center

- Beattie is also planning to operate under Hampton's hybrid model.
- All Hampton students who attend Beattie will be assigned to Pod A.
- Beattie students will attend high school in the morning and Beattie in the afternoon on Mondays and Tuesdays.
- They will learn from home on Wednesdays, Thursdays, and Fridays.

Dr. Loughead said the District's ultimate goal is to move from the hybrid model to a full, in-person return. The goal is to move to full, in-person instruction in October, but when and if that can happen depends on the local status of the virus and the ability to maintain safety under those conditions.

Dr. Loughead answered many questions from Board Members.

#### Hampton Township School District School Reopening Health and Safety Plan

The Administration and Reopening Committee have developed the District's Reopening Health and Safety Plan, as is required by law. The plan outlines in great detail the steps the District will take to prevent the spread of COVID-19 in school and on buses.

The Reopening Health and Safety Plan is built within a template provided by the Pennsylvania Department of Education with Hampton-specific items added as required. The portions unique to Hampton are based upon local conditions; best-practices guidance from local, state, and national health and education experts; the input of parents, teachers, staff and principals; and administrative analysis.

Dr. Loughead referred to the Health and Safety plan, noting that it will direct District safety protocols whether the educational model in place is the Learn at School and Learn at Home Hybrid or full-time, in-person, Learn at School.

The document was provided to the Board for review, and Board Members are expected to vote on adoption on August 10. The full plan, along with other reopening documents and presentations, can be viewed on the District website's COVID-19 page <a href="here">here</a>, and is summarized below:

Facilities Cleaning, Sanitizing, Disinfecting and Ventilation		
Requirement(s)	Strategies, Policies and Procedures	
* Cleaning, sanitizing, disinfecting, and ventilating learning spaces, surfaces, and any other areas used by students (i.e., restrooms, drinking fountains, hallways, and transportation)	Hampton Township School District will align its practices with the guidance provided in the Pennsylvania Department of Education's Preliminary Guidance for Phased Reopening of Pre-K to 12 Schools and the Center for Disease Control (CDC) Considerations for Schools guidelines. These procedures include daily cleaning and disinfecting frequently touched surfaces and objects within the school and on school busses, specifically desks, door handles and sinks, by using multi-surface cleaner & disinfectant. Additionally, all of the HVAC systems have undergone inspection and adjustments will be made to filters and outdoor air use for ventilation.  Hampton Township School District will use available grant funds and local resources to procure adequate cleaning, sanitizing, and disinfectant supplies meeting OSHA and CDC requirements for COVID-19. Training on cleaning, sanitizing, disinfecting, and ventilation protocols will be provided to all employees, especially custodial and maintenance staff - CDC Cleaning & Disinfecting Community Facilities, CDC Cleaning & Disinfecting Your Facility.

*Classroom/learning space occupancy that allows for 6 feet of separation among students and staff throughout the day, to the maximum extent feasible	Classroom/learning spaces will be organized with at least three to six feet separating desks. All extraneous furniture will be removed from classrooms to assist in maximizing spaces between students. Additionally, the District will consider alternative scheduling options to assist with social distancing efforts to comply with current health and safety guidelines	
* Restricting the use of cafeterias and other congregate settings, and serving meals in alternate settings such as classrooms	The use of congregate settings will be staggered and the capacity of which those spaces will be used will be reduced considerably. Additional seating will be provided to assist in reducing the capacity of cafeteria seating.	
* Hygiene practices for students and staff including the manner and frequency of hand-washing and other best practices	Students will be encouraged and provided with transition time to accommodate hand washing during specific times of the school day. Handwashing supplies in all areas of school buildings will be provided.	
* Posting signs, in highly visible locations, that promote everyday protective measures, and how to stop the spread of germs	Signage for handwashing will be displayed to remind students of proper handwashing procedures.

Monitoring Student and Staff Health		
Requirement(s)	Strategies, Policies and Procedures	
*Monitoring students and stafffor symptoms and history of exposure	Parents and guardians will be given a list of COVID-19 symptoms and asked to take their students' temperatures each morning, keep their child home if feverish or exhibiting symptoms of COVID-19, and report instances to the school nurse. Staff will be given a list of COVID-19 symptoms and asked to take their temperature each morning, stay home if feverish or if exhibiting symptoms of COVID-19, and report instances to the school nurse. All students will be additionally scanned for a fever of 100 degrees or higher upon entrance to school. The nursing staff will check student and staff temperatures if symptoms appear while at school. Parents, guardians, students and staff will be asked to report any history of exposure to the school nurse. The nursing department will track student history of exposure and the District Office will track employee exposure. School Nurses and the District Office will work collaboratively regarding information, cases, and exposure. Each school has an isolation area (separate from the established nursing suite), which will be used for staff, students, or visitors who demonstrate COVID-19 symptoms while at school. These isolation areas will be used to house students until their parents/guardians arrive to retrieve them. Immediate pick-up will be mandated.	
* Isolating or quarantining students, staff, or visitors if they become sick or demonstrate a history of exposure	Students, staff or visitors who exhibit symptoms of COVID-19 or a history of exposure will be sent home immediately. Students, staff, or visitors who exhibit symptoms of COVID-19 or a history of exposure must contact their health care provider and/or be tested for COVID-19. Testing results should be reported to the Allegheny County Health Department and to the School Nurse. The School Nurse will immediately notify the building principal and District Administration. Allegheny County Health Department will lead contact tracing and will notify families directly. Staff, students, and visitors must then follow current Allegheny County Health Department guidelines for quarantine and additional testing.	
* Returning isolated or quarantined staff, students, or visitors to school	Students and staff who present as positive or are contact traced to a positive case will be documented. DOH guidelines will be followed for the appropriate closure of the area where the case presented in the building, isolation/ quarantine requirements and the DOH return to work/school parameters. Staff and students will return to in-person school after current Allegheny County Health Department quarantine and isolation guidelines have been followed and when medically cleared by a physician or testing results. ### **Community Member**

:32

What happens if the Hybrid Plan is not adopted by the Board next week? What is the backup plan?

#### **Community Member**

2:06

- Noted that anecdotally, because of quick transition to online learning, the pace and content weren't up to usual Hampton School District standards.
- Asked when the District would evaluate where students are, and how it would measure the efficacy of the educational program since March.

#### **Community Member**

6:18

- Stated his concern that two days of hands-on instruction would not be enough for students enrolled at A.W. Beattie to receive the hands-on instruction the programs there require.
- · Asked that Board Members on Beattie's Board relay those concerns.
- Acknowledged that Beattie and the District have to work within the state parameters and that safety must be a primary concern.

#### **Community Member**

8:47

- Sits on the reopening committee.
- Stated that in light of all information heard, she feels the Hybrid Model is a good option.
- Has talked to many people in the community, and wanted to bring some comments to the Board, seeking adjustments to the elementary plan:
  - At the elementary level, if the goal of hybrid is less exposure, that can't quite be done with kids going to day care the other three days, or being sent to somewhat elderly grandparents, or to a YMCA program that might expose them to kids across the county.
  - It works well with the assumption that one parent stays at home, which is her situation. But people who have to work can't leave their elementary age students home alone.
  - Noted that faculty is exposed to all students, since they are at school all five days.

#### **Community Member**

18:25

- Will there be a different standard for absenteeism in the hybrid model, since parents must keep students who have symptoms at home?
- · Sought clarification on elementary classroom mask breaks.

#### 23:05

- Said she has chosen to participate in the hybrid model instead of Hampton Online Academy. Asked if she
  understood correctly that there is a chance that the District would switch to a full-time, in-school learning in
  October. Later asked how much advance notice parents would get of a switch.
- Asked how the decision to go from hybrid and six-foot social distancing it allows to full open would happen, considering the spike in cases in Allegheny County.
- Implored the District to keep parents informed so they can make the best decisions possible before school starts.
- Are there guidelines coming that determine what happens if there is an outbreak in a local school?
- Asked for more details regarding a student's transition between Hampton Online Academy and a Hampton School, and if a parent could transition their child back to HOA if the District goes to a fully in-school model, and how grade level of student impacts that.
- How will special classes be handled in the hybrid model?
- How will a child who has to quarantine at home for 14 days, participate in school?

#### **Community Member**

36:55

- Appreciates the effort and time put into the plan.
- Has a high school and a middle school student, and has concerns about HOA:
  - Couldn't find much data on the education offered compared to other cyber schools and has concerns about quality.
  - Does HOA offer all of the classes that the high school offers? If the HOA doesn't offer the AP classes we want, could the District accept AP classes taken from other cyber schools?
- Understands that four days of classes each week will stream online. Could parents opt for their children to learn exclusively through those streamed classes?

- Are parents required to sign a liability waiver to send children to school?
- Will the same teacher teach a particular class for the entire week?
- Asked for some comparison between what North Hills is doing with entirely remote learning and what Hampton is recommending.
- Asked if Hampton teachers couldn't provide 100% on-line education for students as an alternative to HOA.

#### **Community Member**

56:15

- Works at a manufacturing company, and notes that safety and meeting customer needs isn't an either/or proposition, and it shouldn't be for schools, either. Both are important.
- Asked if the county health department has considered the hybrid program's impact on community spread, considering that some students will be gathered in community-based programs.
- Stated that if the goal is to educate students, in-school education is the best way. Asked what conditions
  would allow the District to transition to a fully in person education model.
- Asked if face shields are allowed in place of a mask.

#### **Community Member**

1:01:39

- Asked how many students were enrolled in HOA prior to COVID, and noting it is a small percentage of total district enrollment, asked the Board to consider whether this is really a good option for parents.
- Questioned whether a school could truly be deep cleaned in a single day.

- Thinks the reliance on childcare for elementary age students means enough potential exposure that the District may as well open schools to all students every day.
- Noted that the county has had 99 cases of COVID since the pandemic started, and most have recovered.
- Suggested surveying parents with a yes/no question: Are you willing to send your students back to school?
- The plan did not really address what pediatric doctors are saying, vs what the county health department is saying.

1:07:38

- Stressed the importance of students' contact with their teachers, and said that's what was missing with the
  online education her children participated before. That's why she hopes to send her children back to Hampton
  schools.
- Said for her family, it would be best to have Hampton teachers livestreaming from their classrooms every day, with all students at home. Families could chose to do social activities with their children.

#### **Community Member**

1:09:40

- Stated his understanding of CDC guidance is that masks are required only when six feet of social distancing is not possible.
- Noted the District isn't bringing all students back to the classroom at once to facilitate social distancing, and that desk shields would be used, and asked if that didn't mean that students should be able to go without a mask.
- Said masks would be especially difficult for elementary students.

- Stated her family moved into the District expecting a Hampton education with Hampton teachers, and she finds the Hampton Online Academy an unacceptable option.

- Requested more information on what at-home learning would be like for younger students, particularly students whose parents can't provide constant hands-on guidance.
- Asked if parents whose children are social distancing in a pod together could request that their children be in the same Learn at School/Learn at Home group together, so that childcare could be shared.
- Could you push the opening of school back a couple of weeks to further develop a plan and prepare?
